The undersigned as RENTER (including any and all RENTERS signing the Agreement), hires from AquaTime Rentals, LLC as OWNER, the boat listed above, on the following terms and conditions.

Navigation of boats is confined to inland waterway known as Eagle Mountain Lake, Fort Worth, TX.

RENTER acknowledges that the boat is the rightful property of AQUATIME RENTALS, and further acknowledges that he received said boat in good and safe mechanical and seaworthy condition. RENTER agrees to return said boat and all accessories and equipment to AQUATIME RENTALS in the same condition as RENTER received it. Boat is equipped with \_\_\_\_\_ **life jackets**, first aid kit, whistle, paddle, anchor and line, fire extinguisher, spotlight, and a full tank of fuel.

RENTER agrees to pay to AQUATIME RENTALS the cost of replacing lost equipment and the cost of repairing damages to, and caused by, the boat including parts, labor expenses of transporting said vessel or other property to and from point of repair, **all towing charges**, including, **but not limited to all towing charges as a result of grounding or beaching of the boat**, regular rental fee covering time said vessel is out of service as a result of damage, and any collection cost and / attorney fees necessary to secure reimbursement. It is understood that any security deposit ("Deposit") will be used for payment of all or part of the above cost up to its full amount. Cost in excess of the Deposit shall be paid by the RENTER to the AQUATIME RENTALS on demand. **INITIAL HERE**

RENTER agrees to pay AQUATIME RENTALS on demand all time, fuel and other charges applicable to the rental of the boat at the rates or in the amounts specified herein.

RENTER who signs to accept the terms of this Rental Agreement certifies that he or she is 21 years of age or over.




